_____ Care Provider will be held harmless against illness, loss or injury to this dog while in her care.

_____ If the dog's stay is for more than three paid days, Care Provider will provide:
 Routine grooming service (\$29 per service), which may include the following: cleaning ears; nail trim; trimming around anal area; shampoo, fluff dry and comb out.
 If requested, Care Provider will provide full grooming service which includes routine grooming service plus trimming / clipping coat (additional \$20 per service for a total of \$49).
 Care Provider will not provide grooming if: owner requests it not be performed; in Care Providers opinion, the dog's coat is too matted to perform a routine grooming; dog will not tolerate a grooming or if Care Provider does not have sufficient time to perform the grooming service.

_____ Payment in full (cash or check – NO credit cards) of all services rendered will be paid upon pick-up of the dog.

_____ Minimum of two paid days is required.

_____ This agreement will remain in effect until a new Master Boarding Services Agreement is signed by both Owner and Care Provider.
